Lisses, Runcorn - October 2018; the **AURES Group** has acquired 100% of the shares of the American company **RETAIL TECHNOLOGY GROUP Inc** (RTG) on October 16, 2018.

RTG is not only one of the main US providers in terms of services, maintenance and support in the field of POS solutions and equipment, but above all the only one to propose a complete offer - from installation to help desk and hotline - for the POS hardware but also for the software platforms.

The Company provides tailored services to chains of at least 500 points of service, and manages a portfolio of more than 30,000 sites; it employs over 350 people and generated revenues of approximately US\$40 million in its last fiscal year.
